Police Sargent Rachel Clark, Inspector Mark Nicholson and PCSO Mike Storey attended to speak regarding the recent Illegal raves.

Summer raves in local quarries have been a problem again this year. The most recent was held at Barnes Close Quarry when it was decided that it was safer to keep the party goers contained in one area rather than breaking the party up, which could cause incidents of public disorder as they leave site. Inspector Nicholson confirmed that each time they are notified of an illegal rave they have to weigh up whether it is safe to break up or better to contain party goers and prevent the event from getting bigger. With limited resources this is sometimes the safest option.

Inspector Nicholson said that he understood the frustrations of residents who are affected by the events but made it clear that the Police are trying to put measures in place to stop them from happening as they believe prevention is the key. They would ask members of the public, Parish Councilors or local publicans to contact the police with any information that they may have which leads them to believe an event is about to take place in the area so that officers can be deployed to prevent the party from getting underway. During the coming winter PC Greg Powers will be working to raise awareness, maybe "Rave Watch" to help with prevention.

The Chair thanked the officers for taking the time to attend and give this update.

Public Discussion

The following matters were highlighted:

- 1. Cllr Townsend congratulated Her Majesty Queen Elizabeth II on becoming our longest reigning monarch. Cllr Turner said that there was a lovely Church service that morning to honour the event.
- 2. There was concern at the amount of overflowing bins experienced within the parish over the last few weeks. The Clerk to write to the Landscape group, for the attention of WAGS explaining our concerns and copy the correspondence to Cllr Ham.
- 3. Cllr Neesam said that the street cleaning wagon has not been seen in Church Street, High St and outside of the Kings Head for some time. It should be every 10 weeks which it is not currently. Clerk to write to the Landscape group and request that it attends during the middle of the day when the majority of the cars will not be present.
- 4. Cllr Horler had emailed to say that there has been another very successful Irish Weekend held at The Kings Head with people coming from as far and wide with some people making it their annual holiday and staying for 2 weeks. Cllr Horler said that she felt that the annual event should be recognised as it brings in all sorts of income into the village.
- 5. Cllr Horler has spoken with Jane Boldy the Conservation officer at MDC and voiced her fears regarding the house next door to the Kings Head and the lack of response from enforcement regarding the changes to the appearance.

- It was agreed that the date previously agreed for the Local Plan Part II meeting at the Hub needs to be changed from Friday 2nd October to Friday 25th September 2015 Clerk to amend posters which are currently on the village notice boards.

5 Reports

5.1 PCSO report – PCSO Mike Storey did not provide a report.

The minutes resulting from the PCSO Frome Rural Beat North had been circulated to all Councillors for their perusal.

5.2 County Councillor reports

County Cllr Ham said that August had been a quiet month. Somerset and Devon County Councils have put in a joint bid on the 4th September re devolution.

Hinckley C will probably get the go ahead in the next 6 weeks.

Cllr Ham confirmed that he has been involved with the Somerset Rivers Authority who have now agreed with the Inland Drainage group that money should be raised by Precept. This will now have to be agreed at full Council meetings prior to going to Parliament in London. If agreed this would be implemented the year after next.

5.3 <u>District Councillor Reports</u>

District Cllr Townsend reported that he had attended the Licensing sub-committee. They had to consider the license for a party on the Shepton Mallet to Wells road opposite Shepton Mallet Crematorium. Police raised strong objections due to the speed of traffic on the road along with concerns over how the number of people attending would be controlled.

Cllr Townsend also commended the Licensing board who managed to secure an extension for the Coleford Village day, covering Saturday as well as the originally requested Sunday, within 3 days.

Wind turbines – The West Pennard application recently held its 4 day public enquiry the outcome of which will not be available for some time (6 months). The appeal for the proposed 4 x 80m wind turbines at Torr Works starts this week which could take 7 to 8 days to complete.

Cllr Ham reported as follows:

- 1. Mendip District Council have agreed to charge for pre planning advice on a sliding scale relating to size of development. They have also agreed to make a charge of £1500 for any application to move a public footpath.
- 2. The Mendip Housing Company has now had its first meeting. Cllr Ham has been put forward as a Director. Private housing will be built rather than affordable housing to help establish an income stream for the Council.
- 3. During August there have been further talks regarding sharing services with South Somerset. Over the next week a feasibility study will be completed to see if this can be taken any further
- 4. Talks are ongoing with regulatory services to try and get other services ie Police, Landscape group, NCL parking enforcement group etc working together to help become more efficient and financially streamlined.
- 5. The recent Cabinet meeting has spent most of the day looking at how to make the future look financially sound.
- 6. Cllr Ham has met with Henry Gibson who is currently setting up superfast broadband in Trudoxhill and Witham Friary. This may be of interest if the BT broadband, which should be upgraded to superfast fibre optic service before the end of the year, fails to improve the service for some parts of the village.
- 7. The Clerk read out a statement made by Cllr Ham regarding the refugee crisis and how Mendip District Council will respond to the crisis as part of the Local Government Association's coordinated national action plan. Chief Executives of the LGA are currently in discussion with central government about what the role and responsibilities of local councils will be and how any support we give will be funded.

6 Highways and Footpath Issues

6.1 Lead Councillor Report

Cllr Townsends report had been circulated to all Councillors prior to the meeting which highlighted as follows:

- 1. Surface dressing on Anchor Rd, Highbury St has now been completed except for the approaches to Pedestrian Crossings. White lining should take place within the next 10 days and the anti-slip surface approaching the pedestrian crossings should be completed within 28 days.
- 2. Stockhill Bus Stop This has now been removed on the Crescent side as a result of surface dressing. Cllr Ham reported that the bus cage will only be reinstated at the Crescent if written consent is received, which may be forthcoming.
- 3. Defective light on Pedestrian Crossing by Post Office has now been repaired.

- 4. Various gulley's scheduled to be cleared this week.
- 5. Potholes marked up for action on Dark Lane, Springers Hill and by Cherry Gardens Farm.

6.2 Outstanding Issues for Highways & Footpaths

Cllr Turner asked if there had been any news regarding the new footpath at Goodeaves. Cllr Townsend confirmed that it had been reported but no update had been received as yet. Cllr Townsend to follow up.

Cllr Townsend left the meeting at 9pm

6.3 Items reported by Councillors

Street Names – Cllr Banks confirmed that he and Cllr Horler had met with Mike Isherwood and we walked the roads we required naming and he agreed the following:

• Sign at the bridge leading out towards Leigh on Mendip "Underhill" and again at Brookside Cottage, Mr and Mrs St John to be asked for authority by VH.

• Sign at "Springers Hill" to be mounted on the grass verge next to the Grove, Cllr Horler to ask VH the owner for permission

• Sign at "The Grove" entrance, with Parish Council letter requesting permission from Felicity White, The Arches.

• Sign at Glen View with Melanie Moulding's permission (VH to ask) for "Church Street".

• Sign for "The Barton" and "Barton Villas" at entrance on left side opposite the old off licence with owners consent. Parish Council to seek authority as The Barton House is being renovated by a developer.

• The only sign we failed to get was "Norton Hill" above 8 and 16 Church Street as Mike thought that it falls in the same category as Wesley Cottages, Rock Terrace and so on.

Cllr Horler and Cllr Banks were both very pleased with the cooperation and the very nice attitude from Mr Isherwood. He said the signs would not come at once perhaps a month between on each occasion. The authority needs to be obtained by the Clerk to mount the signs in advance.

Harris Vale Complaint – The Clerk read out an email highlighting the problems at the entrance to Harris Vale in Coleford. Cars are constantly parked opposite the entrance which forces traffic from Vobster to drive on the wrong side of the road which causes buses and other vehicles to make it dangerous to exit from Harris Vale. Somerset Highways had directed that the author of the letter should ask the Parish Council to confirm that this was an accurate representation of the problem. After discussion Councillors felt that the Clerk should write acknowledging that we are aware that there are problems like this throughout Highbury Street with uncontrolled bottle necks. The Parish Council believes that there is no Truly effective solution which could be implemented to satisfactorily solve the problem that didn't set an unworkable president somewhere else along Highbury Street; therefore it might be an idea for the author of the Email and neighbouring residents to consider other alternatives to mitigate this issue e.g. purchasing a mirror to be sited appropriately to assist with negotiating onto Highbury Street.

7.3 Present Applications

7.3.1 <u>2015/1676/FUL - The Chapel On The Hill Church Street Coleford</u>

Construction of a new single family house

All Councillors had considered the abovementioned plans. After discussion it was proposed by Cllr Gurd that the application should be refused for the following reasons:

- 1. The new building is architecturally inconsistent / abrasive with all the other properties in that area. (i.e. all the other properties on that flat were built in the early 1800's) and that a significant modern property in such close proximity to the Chapel would detract from the intent of the listing of the Chapel by degrading the aesthetic nature not only of that particular area of Coleford but of the Chapel itself.
- 2. The intended position of the house is right over the site of the old Coal Canal which is of historical interest and mentioned within the Parish plan.
- 3. The suggested parking on the application appears unworkable for 4 cars. We as a Parish cannot tolerate any more street parking on Church Street
- 4. It was questioned if the listing of the Wesleyan Chapel also applied to the plot of land that is attached to it or at least the in the very close proximity to the Chapel as aesthetics are all about proportion, i.e. it would look ludicrous if you built a high rise set of affordable housing next to Buckingham palace.
- 5. It is understood that the Wesley Cottage next to the Old Sunday School has parking rites to park in the Chapel Car Park which is mentioned within their Deeds.

The proposal was seconded by Cllr Turner.

7.3.2 2015/1935/HSE – 2 Hillside, Church Street, Coleford

Construction of a garden store in the rear garden (re submission application 2014/1889/HSE new positions of doors and windows and roof)

All Councillors had considered the abovementioned plans. After discussion it was proposed by Cllr Gurd that the application should be refused on the grounds that:

- In no way can either the 2014 or 2015 submitted application drawings represent a "Garden Shed" and on this basis the application is disingenuous and appears to be designed to deceive.
- The Ridge height of the actual building far exceeds that implied on either of the application / amendment drawings.
- The Elevations of the building don't appear to be consistent with the actual build. This needs to be checked out by enforcement to corroborate / establish the actuality.
- Works have been carried out on the building that do not feature in either the original application or the amended application drawings; indeed there are additional works being undertaken as we consider this application that again do not feature in either of the

- 2014 or 2015 application / amendment thus furthering the belief that this is an application which is designed to deceive.
- The original application required a 106 agreement to be signed, this has not been done therefore should not be approved on that basis alone regardless of the other points now mentioned.

This proposal was seconded by Cllr Talbot.

Highbury Changing Rooms.

Unfortunately, on Village Day, quite a lot of damage was caused to the Gents toilet comprising of pulling from the wall of the hand wash basin and the breaking of the metal/plastic hinges to the access door. I understand that we are asking N E House to indicate a price for rectifying same.

A vehicle collecting equipment after the show also caused ruts in the corner of the football field near the changing rooms and it is CAFC's intention to hire a pneumatic roller to correct same and send the invoice to us. The Clerk read out an email received from CAFC which stated that due to damage to the pitch caused during the Village day they were unable to play at home the following Saturday. Cllr Littlechild confirmed that this was not correct and that they did in fact play. It was agreed that the Clerk will respond to Mr Hansford and ask that they try to rectify the problem by lifting the turf with a fork and then roll using the Football clubs roller. The damage was not done intentionally.

- 11.1 Lead Cllr Evans reported that:
 - Tidied and weeded Church Street gardens.
 - Painted and repaired the Cemetery gate Thanks to were expressed to Cllr Neesams husband for repairing the gate.
 - Cleared and piled up the tree branches which 2 Preachers Vale had left on the green, as well as cutting back stinging nettles as they had not been cut back.
 - Had a telephone conversation with Cheryl Norton to chase up the clearing of both piles of rubbish as well as advising where the branches had come from. Also mentioned the hedge cuttings at no 13 Beacon View, Cheryl Norton said that they will liaise with enforcement department to take this further.

Discussion regarding making inspections of allotments

Cllr Gurd has made a provisional inspection of the Goodeaves allotments and confirmed that there are approximately 1/3 which are unkempt. The Clerk to forward a plan of the allotments so that the tenants can be identified and contacted to assess if they wish continue as tenants. If not it can then be offered to someone on the waiting list.

11.3 Update on the flooding/drainage issues at the Rose and Crown car park

Cllr Ham confirmed that he had spoken with Stuart Finney and Julian Haines who holds the post of Land Drainage and Project Engineer for Mendip District Council. Mr Haines emailed to say that the Parish Council may wish to consider:

"The official position is thus:

legally a person owning lower-level ground has to accept natural land drainage water (that is, spring water, ground water or surface water run-off) from adjacent land at a higher level. The exception to this is where the owner of that adjacent land has carried out "improvements" such that the run-off from the land cannot be considered 'natural' – for example if the entire back garden has been paved over.

This suggests that the owner of the plot to the rear of Rose and Crown Cottages has to accept the natural water flowing off of or out of the playing field.

There was a planning application circa 2003 (subsequently refused) to develop this plot, the planning file is not available online but could possibly be retrieved if need be. We do however have access to some correspondence between Hugh Tetlow the Council's then Drainage Engineer and the Applicant and Case Officer. Hugh recommended that a perimeter cut off drain be provided between the playing field and the proposed development, pdf 030903, the developer responded that there was already a drain present connected to a surface water drainage system, pdf 031218 pg2.

A quick look at the Wessex Water mapping shows there are no public surface water sewers in the area other than the County Council maintained highway drainage system."
